At Edinburgh, and within the Assembly Hall, the 25th day of May 2017 years, at 9.15 am, Session V.

The General Assembly did again convene and was constituted with prayer.

The minutes of Session III being printed and in the hands of members, were submitted and approved.

# COMMITTEE ON CHAPLAINS TO HER MAJESTY'S FORCES

The General Assembly called for the Report of the Committee on Chaplains to Her Majesty's Forces which was given in by the Rev Gordon Craig, Convener.

It was moved and seconded-

# The General Assembly:

- 1. Receive the Report.
- Reaffirm the support of the Church of Scotland for all who serve in Her Majesty's Forces as Chaplains, and thank them for their outstanding service to Royal Navy, Army and Royal Air Force personnel and their families.
- 3. Acknowledge with particular gratitude the dedicated service of Chaplains on

- operations and the immeasurable support shown by their own families.
- Commend to the prayers of all members of the Church of Scotland not just our Chaplains but all who serve in HM Forces and their families.
- Commend to eligible ministers of the Church consideration of service as a Chaplain to HM Forces – Regular, Reserve and Cadet Forces.
- 6. Approve the Armed Forces Covenant described in Appendix 4 of the Report.

It was moved, seconded and agreed as an amendment of Section 6:

After 'Approve' add 'and implement'.

The Deliverance as amended was then agreed.

The Moderator addressed those Chaplains to Her Majesty's Forces who were present.

Air Marshal Stuart Atha CB DSO MABSC RAF, Deputy Commander Operations was then invited by the Moderator to address the General Assembly.

# MISSION AND DISCIPLESHIP COUNCIL

The General Assembly called for the Report of the Mission and Discipleship Council which was given in by the Rev Norman Smith, Convener.

It was moved and seconded-

# The General Assembly:

- 1. Receive the Report.
- Encourage Kirk Sessions to explore how they might make use of the Conversations in Worship material.
- 3. Encourage the whole Church to use 'Pray Now: Word of Life' in daily devotions and public worship and to note the new How We Pray section.
- Welcome the launch of the new Weekly Worship (formerly Starters for Sunday) pages and commend the efforts made to enhance content and accessibility.
- Note the take-up of the online daily memes shared through the Church of Scotland social media channels and encourage their widespread use.
- Welcome CARTA's development of its new 360 degree resource as a way of promoting the use of art and architecture in worship and outreach.
- 7. Urge Kirk Sessions to engage with the children and young people faith formation resources arising from Learn: Community of Faith conferences and to promote their use within the wider congregation.
- Urge Kirk Sessions to use the Learn: Children & Young People publication and to promote its use in the wider congregation.
- Note the continuing development of the Theology of Children and Young People identified in the interim report.
- Instruct the Council to address the proposals contained within its report on the subject of the National Youth

- Assembly Review and to bring an interim report to the General Assembly of 2018.
- 11. Instruct the Council to continue its work on developing the eldership by addressing the proposals presented in the report from the Eldership Working Group.
- 12. Urge Presbyteries and Kirk Sessions to engage fully in the Year of Young People initiative in 2018.
- 13. Encourage Kirk Sessions to consider using Future Focus as an envisioning and planning resource at appropriate moments in congregational life.
- 14. Encourage Kirk Sessions in rural settings to engage with and utilise the support that has been developed for them.
- 15. Encourage Kirk Sessions to use the Pastoral Care resources as appropriate.
- 16. Instruct Presbyteries, when training Elders as moderators of their own Kirk Session, to use the training resource that has been developed specifically for this situation.
- Encourage Kirk Sessions to promote the use of the online Office Bearers resource.
- 18. Urge Kirk Sessions to provide a Learning Disability Contact and engage with the support that has been developed for them in the area of learning disabilities.
- 19. Encourage Presbyteries and Kirk Sessions to use and share the Life Stories videos and transcripts as a means of building confidence in articulating faith and to promote their use throughout the Church.
- 20. Urge Kirk Sessions to support members in sharing their faith, and to use the Sharing Faith resource where appropriate.
- 21. Urge Presbyteries and Kirk Sessions to use the discipleship publications Learn: Exploring Faith and Learn: Understanding our Faith.

- 22. Encourage Presbyteries and Kirk Sessions to promote the use of Learn Online
- 23. Encourage Presbyteries and Kirk Sessions to explore opportunities for pioneering forms of mission and to engage with the Fresh Expressions Development Worker.
- 24. Encourage Presbyteries, in conjunction with other denominations, to invite the Fresh Expressions team to run Fresh Expressions training events.
- Encourage Presbyteries and Kirk Sessions to promote digital subscription to Life and Work.
- 26. Approve the theme of 'Stories E.T.C.' to run from 2018 to 2020 and commend it to the whole Church.

It was moved, seconded and agreed as an amendment of Section 5:

Delete 'memes' and substitute 'image macros'.

It was moved, seconded and agreed as an amendment of the Deliverancer:

*Add a new Section 10 and renumber:* 

Affirming the importance of including children and young people in the community of faith', and noting the Council's intention to focus on the question 'How and when are children and young people to be fully involved in the Sacrament of Holy Communion:

- Instruct the Council to consult with Presbyteries and Kirk Sessions in order to determine the extent to which the Church is finding Act V 2000, the Sacraments Act, to be pastorally helpful in the discipleship of children and young people;
- ii. Instruct the Council, in consultation with the Theological Forum, to reexamine the Church's current

- understanding that all children must be baptised prior to sharing in the Lord's Supper, within the context of the New Testament and the Church's Confession of Faith:
- iii. Instruct the Council to produce resources to help ministers, Sunday School volunteers and congregations to know how best to include children and young people at the Lord's Table.

It was moved and seconded as an amendment of Section 10:

Amend to read:

Instruct the Council to address the proposals contained within its report on the subject of the National Youth Assembly Review and as part of that process to create a working group of 14 people comprising seven members of the Mission and Discipleship Council and seven young people (including former and current members of the National Youth Assembly. youth workers and other young people), young people to form the majority of the group and the group to be co-chaired by a young person and a member of the Council, and to bring an interim report to the General Assembly of 2018 considering the vision, scope, structures and resourcing that engage young people in spiritual formation and decision making processes at all levels of the Church.

On a vote being taken For or Against it carried For.

It was moved and seconded as an amendment of the Deliverance:-

Add a new Section 11 and renumber:

Instruct the Council to continue with the National Youth Assembly beyond 2019 unless and until any alternatives have been proved at least as successful.

On a vote being taken For or Against it carried Against.

It was moved and seconded as an amendment of the Deliverance:

Add a new Section 13 and renumber:

Acknowledge and congratulate Scripture Union on its 150<sup>th</sup> anniversary year, giving thanks to God for the work of Scripture Union Scotland with our nation's young people.

The General Assembly suspended their sitting at 12.38 pm until 2 pm.

It was moved, seconded and agreed as an amendment of Section 19:

After 'videos and transcripts' add 'and Talking Jesus materials'.

It was moved, seconded and agreed as an amendment of the Deliverance:

Add a new Section 26:

Recognise with sincere appreciation the outstanding contribution made by Rev Dr Roddy MacLeod as Editor of 'Na Duilleagan', the excellent, Gaelic Life & Work insert during the past 37 years and commend the Council for its innovative provision of a digital version of 'Na Duilleagan' alongside its paper version of this excellent resource.

It was moved, seconded and agreed as an amendment of the Deliverance:

Add a new Section 27:

Instruct the Council to consider the development of a National 'Season of Invitation' as a call to mission across the Church to be nationally driven and locally delivered and report to the General Assembly of 2018.

The Deliverance as amended was then agreed.

#### NATIONAL YOUTH ASSEMBLY

The General Assembly called for a Report from the 2016 National Youth Assembly which was given in by Mr Andrew MacPherson, Moderator of the National Youth Assembly.

Questions were addressed to Youth Representatives who had attended the National Youth Assembly.

The Moderator expressed appreciation to Mr Macpherson for his contribution to the Youth Assembly.

# THEOLOGICAL FORUM

The General Assembly called for the Report of the Theological Forum which was given in by the Very Rev Professor lain Torrance, Convener.

It was moved and seconded-

# The General Assembly:

- 1. Receive the Report.
- 2. Note the Forum's range of activities and support given to the Church.
- 3. Receive the report "An Approach to the Theology of Same-Sex Marriage" as a resource to the Church and commend it as a basis for study and discussion.
- Invite the Church to take stock of its history of discrimination at different levels and in different ways against gay people and to apologise individually and corporately and seek to do better.
- 5. Instruct the Legal Questions Committee to undertake a study of the matters which would require to be addressed in any new legislation

permitting Ministers and Deacons to officiate at same-sex marriage ceremonies, with a view to presenting a Report to the 2018 General Assembly.

It was moved and seconded as a countermotion to Section 1:

Receive the Report with the exception of Sections 3–5 of the Deliverance, Section 3 of the Report and the Appendix 'An Approach to the Theology of Same-Sex Marriage'.

On a vote being taken there voted for the motion 298 and for the counter-motion 149 and the General Assembly resolved accordingly.

It was moved and seconded as an amendment of Sections 3 and 4:

Add a preface consisting of the following wording to Section 3 of the Deliverance and renumber Section 3 as sub-section a) and Section 4 as sub-section b):

'Recognising and affirming the Church's existing doctrine and practice in matters of human sexuality, as in particular contained in (i) the deliverance in 2011 of the General Assembly on the Report of the Special Commission on Same-Sex Relationships and the Ministry in which the Church stated both that "homophobia is sinful" and that the Church does "not include in the concept of homophobia both the bona fide belief that homosexual practice is contrary to God's will and the responsible statement of that belief in preaching or writing"; (ii) the Report of the Working Group on Human Sexuality: Believing in Marriage received by the General Assembly in 2012; and (iii) the terms of the Ministers and Deacons in Civil Partnerships and Same Sex Marriages Act (Act I 2015):'.

It was moved and seconded as an amendment of Sections 3, 4 and 5:

Add a preface consisting of the following wording to Section 3 of the Deliverance and renumber Section 3 as sub-section a), Section 4 as sub-section b) and Section 5 as sub-section c):

'Recognising the Church's doctrine and practice in matters of human sexuality and marriage:'.

On a vote being taken between the proposed amendments, there voted for the first 251 and for the second 274 and the General Assembly resolved accordingly.

On a vote being taken For or Against the preferred amendment (of Sections 3, 4 and 5), there voted For 361 and Against 94 and the General Assembly resolved accordingly.

It was moved and seconded as a countermotion to Section 3:

Delete 'and commend it as a basis for study and discussion'.

With the permission of the General Assembly, the above counter-motion was withdrawn.

It was moved and seconded as a countermotion to Section 3:

Receive the report 'An Approach to the Theology of Same-Sex Marriage', with the omission of sections 1.8 to 1.10, as a resource to the Church and commend it as an initial contribution for study and discussion alongside the 2012 Report 'Believing in Marriage'.

On a vote being taken between the motion and the counter-motion, there voted for the motion 269 and for the counter-motion 191 and the General Assembly resolved accordinaly.

It was moved, seconded and agreed as an amendment of Section 3:

# Add at the end:

and instruct the Ecumenical Relations Committee to invite comment and feedback from our ecumenical partners and report to the General Assembly of 2018.

It was moved and seconded as an amendment of the Deliverance:

# Add a new Section 4:

Instruct the Forum to engage in further reflection on the issues surrounding samesex marriage and bring to a future General Assembly a further report that deals with the broad spectrum of views on this issue.

On a vote being taken For or Against the amendment, there voted For 127 and Against 284 and the General Assembly resolved accordingly.

It was moved, seconded and agreed as an amendment of the Deliverance:

# Add a new Section 6:

Urge the Forum, in consultation with other Councils, to investigate theologically the theme of reconciliation, with particular reference to the divisions within the Church of Scotland, Scottish churches and Scottish society concerning same-sex marriage.

The Deliverance as amended was then agreed.
