FUNDING SOURCES FOR CHURCHES

The main directory for locating funding bodies in Scotland is SCVO- https://fundingscotland.com/ this however included many funds which are not available to churches- Although not exhaustive the list below indicates the main sources of funds available to churches. There may be funds distributed by individual Local Authorities such as Common Good Funds and funds set up by many wind farms which have a very local catchment.

Church of Scotland Consolidated Fabric Fund

Loans and grants are available from this Fund which is operated by the Church of Scotland General Trustees for the purchase, building, repair and improvement of Churches, Halls and Manses and in certain other special cases as determined by the General Trustees. All applications must be submitted via the local Presbytery Office.

Church of Scotland Presbyteries

Some local Presbyteries hold funds from which grants can be made for fabric repair and improvement. Apply to the relevant Presbytery Clerk.

The National Lottery Heritage Fund

The NHLF support a broad range of heritage projects throughout the UK. Their vision is for heritage to be valued, cared for and sustained for everyone, now and in the future. They fund heritage projects from £10,000 to £10million. Comprehensive information is available on their website: What we fund | The National Lottery Heritage Fund.

There are currently two programmes available for Scotland. Each programme has a different application process and must take all four investment principles into account, namely saving heritage, protecting the environment, inclusion, access and participation and organisational sustainability.

- Grants from £10,000 to £250,000: <u>National Lottery Heritage Grants £10,000 to £250,000 | The</u> National Lottery Heritage Fund
- Grants from £250,000 to £10million: <u>National Lottery Heritage Grants £250,000 to £10million</u> The National Lottery Heritage Fund

Historic Environment Scotland (HES)

Under the Historic Environment Repair Grant programme HES offer funding for projects and activities relating to Scotland's historic environment. They offer grants from £1,000 to £500,000 under three grant schemes Express (£1,000 to £25,000), small grants (£25,001 to £100,000) and large grants (£100,001 to £500,000).

IMPORTANT INFORMATION PRIOR TO MAKING AN APPLICATION FOR A HES AND NLHF:-

Funding from both organisations is awarded on the condition of a monitoring period of 15 years which means that if a building is disposed of during the period grants awarded are required to be paid back on a pro-rata basis. Given the disparity between the monitoring periods and the 5-year Presbytery Plan, it is essential that both Presbytery and the General Trustees are consulted PRIOR to making an application. An assessment will be made as to whether the application will be supported based on the overall robustness of the relevant buildings' place in the current mission plan and its long-term future.

The General Trustees will then provide a letter of support for submission with the application. Your application is unlikely to be approved without the necessary letter of support.

National Churches Trust

Grant programmes are available to places of worship to allow them to continue to serve people, communities and visitors in all sorts of ways. Benefact Trust

The Trust funds Christian charities and churches who are making a positive impact on their communities. Grants are awarded to repair, restore and improve church buildings. There are different grants available, the main grant relating to building maintenance is their building improvement grant which seeks to protect and enhance Christian buildings by supporting direct capital costs for specific works. Regular maintenance is not grant funded.

Baird Trust

The Baird Trust is a Scottish Charity assisting the funds and schemes of the church in Scotland. It was originally for Presbyterian denominations – Church of Scotland, United Free Kirk, etc. However, today they offer grants to all denominations and churches (including synagogues). The majority of grants (up to £10,000) are for purposes relating to fabric and building improvements, but we also offer funding for mission and outreach, including staffing costs: http://www.bairdtrust.org.uk/

Bellahouston Bequest Fund

This fund gives grants to Evangelical Denominations in the Greater Glasgow area to assist with the building and repairing of Churches and Halls and the promotion of religion. Dundee Historic Environment Trust

Set up in 2004 to promote and encourage the conservation, protection and improvement of the historic architectural and physical environment of Dundee. A Sinclair Henderson Trust

The Fife Environment Trust

was formed in 1997 as an independent non-profit making company to distribute landfill tax funds under the 1996 Landfill Tax Act which was the first 'green tax' introduced in the UK. Now an Approved Body, FET is permitted to receive Scottish Landfill Communities Fund (SLCF) money from landfill operators and distribute this to eligible projects. Fife Council, in its capacity as a landfill operator, is the primary contributor to the fund. FET is one of the key Funding Bodies in Fife awarding grants for community, environmental and heritage projects across Scotland to benefit the lives of those living in the vicinity of landfill sites and/or waste transfer stations: https://www.fifeenvironmenttrust.org.uk/

Garfield Weston Foundation

Gannochy Trust

The Gannochy Trust was founded in 1937 and provides donations only to organisations in Scotland with a preference for charities in the Perth area. However the Trust does welcome applications from elsewhere in Scotland from registered charities only. Listed Places of Worship (LPW) Grant Scheme

The Listed Places of Worship (LPW) Grant Scheme gives grants covering the VAT on repairs of over £1,000 to listed buildings used as places of worship. You can also submit one claim in any 12-month period that is less than £1,000, but more than £500. The Scheme is run by the Department for Culture, Media and Sport (DCMS) and managed by East Midland Business Ltd. Clothworkers Foundation

Applications welcome for capital costs. The size of grant awarded will depend on a number of factors including the size of the organisation and the cost and scale of the capital project. Must be able to demonstrate that the work carried out from the building fits within one or more of their programme areas (see categories on the above link), and that at least 50% of service users benefiting from the capital project are from one or more of those groups: https://www.clothworkersfoundation.org.uk/what-we-fund/#open

FNDING FOR MORE SPECIALIST WORKS

War Memorials Trust

Funds repairs and conservation to best conservation practice assessed on the basis of need. Currently offer up to 50% of eligible costs and up to £5,000 for non-freestanding and up to £20,000 for free standing memorials: http://www.warmemorials.org/grants/

Society of Antiquaries Morris Fund

Morris Fund, was formed in 1939 using a bequest to the Society from May Morris, the younger daughter of William and Jane Morris. Only support work carried out under the principles of the Society for the Protection of Ancient Buildings (SPAB), which was founded by her father. Fund smaller programmes of work concerned with the conservation of decorative or non-structural features inside the building. This might include, for example: stained glass windows, sculpture, furniture, internal monuments and tombs and wall paintings. The object must have been made no later than 1896 (the year of William Morris's death), even if it is in a building which is older: https://www.sal.org.uk/wp-content/uploads/2020/02/2016 11 Morris grants.pdf

Worshipful Company of Glaziers

Grants are available up to £6,000 to ecclesiastic and other public buildings exclusively for the conservation of historic and/or artistically significant stained and architectural glass. Decisions are based on the significance, conservation urgency and quality/appropriateness of the methodology. A condition report is required: http://glazierscompany.org.uk/conservation-grants/
