  - (iii) Transmit again the Overture, as amended, to the Presbyteries for their consideration under the provisions of Article VIII of the Articles Declaratory in Matters Spiritual (1921), directing that returns be sent to the Principal Clerk not later than 31 December 2024, and noting for the avoidance of doubt that the Book of Confessions referred to in the Overture will contain the Apostles' Creed, the Nicene Creed, The Scots Confession, The Westminster Confession of Faith and the 1992 Statement of Faith.

It was moved, seconded and agreed as an amendment of section 2(ii) of the Deliverance:

Add at the end:

and also amended as follows:

At 1.1, in relation to Article II, after:

"II. The subordinate standards of the Church of Scotland are contained in its Book of Confessions."

Add:

"The Book of Confessions contains the Apostles' Creed, the Nicene Creed, The Scots Confession, The Westminster Confession of Faith and the 1992 Statement of Faith."

At 4.1, change the last paragraph of the Preamble from that in the print to: "The subordinate standards of the Church of Scotland are contained in its Book of Confessions. The Book of Confessions contains the Apostles' Creed, the Nicene Creed, The Scots Confession, The Westminster Confession of Faith and the 1992 Statement of Faith. The Church recognises liberty of opinion on such points of doctrine as do not enter into the fundamental doctrines of the Faith, claiming the right, in dependence on the promised guidance of the Holy Spirit, to formulate, interpret or modify its subordinate standards: always in agreement with the Word of God and the fundamental doctrines of the Christian Faith expressed in the Apostles' and Nicene Creeds - of which agreement the Church itself shall be sole judge."

Section 2(ii) as amended was then agreed.

It was moved and seconded as an amendment of the Deliverance:

Add a new section 3 and renumber:

3. Instruct the Theological Forum to produce an online companion volume to the Book of Confessions, containing the additional documents mentioned in the Second Article Declaratory (namely: "The Directory for the Public Worship of God," "The Form of Presbyterial Church Government " and "The Form of Process") and the Westminster Larger and Shorter Catechisms.

On a vote being taken For or Against the proposed new section 3 of the Deliverance, there voted

For 220 and Against 123 and it carried For.

The Deliverance as amended was then agreed.

It was moved and seconded as an amendment of the Deliverance:

Add a new section 3 and renumber:

Instruct the Theological Forum to prepare a report on reserved sacrament with recommendations for implementation, to be presented by the General Assembly of 2025.

On a vote being taken For or Against the proposed new section 3 of the Deliverance, there voted For 65 and Against 271 and it carried Against.

It was moved and seconded as an amendment of the Deliverance:

Add a new section 3 and renumber:

Instruct the Theological Forum to prepare a report on historically held open models of baptism, with particular consideration given to the requirement for membership and observance only within Sunday morning worship, to be presented with recommendations by the General Assembly of 2025.

On a vote being taken For or Against the proposed new section 3 of the Deliverance, there voted For 30 and Against 317 and it carried Against.

The Deliverance as moved was then agreed.

At Edinburgh, and within the Assembly Hall, and also via video-conference using Zoom Meetings, on the 21st day of May 2024 at 9.15 am.

#### **SESSION 8**

The General Assembly did again convene and was constituted with prayer.

The Minutes of Sessions 1-4, being available in the Assembly Paper, were submitted and approved.

# PROCEDURE COMMITTEE

The General Assembly called for the Report of the Procedure Committee which was given in by the Rev Michael Mair, Convener.

#### SOCIAL CARE COUNCIL

The General Assembly called for the Report of the Social Care Council, which was given in by the Rev Thom Riddell, Convener.

It was moved, seconded and agreed:

# The General Assembly:

- 1. Receive the Report.
- 2. Recognise the continued pressures with recruitment across the sector, commend the workforce for all they are continuing to achieve in the face of that, and encourage the sharing of recruitment resources across wider Church of Scotland networks.
- 3. Note the initiative being piloted with Scottish Workforce Chaplaincy and endorse the move to ensure that spiritual wellbeing remains a priority for the CrossReach workforce and those it supports.
- 4. Commend the ecumenical and interfaith efforts to bring attention to the issue of Fair Work in social care and endorse further collaboration in this area.
- 5. Express alarm about the cuts to vital care services being experienced by CrossReach and other care providers in the social care sector and ask CrossReach, working with the Faith Action Programme Leadership Team, to raise awareness about the crisis in social care with Presbyteries and congregations and to make representations to the Scottish Parliament and Scottish Government.
- 6. Note the extensive consultation exercise undertaken by CrossReach to set a clear way forward which will allow it to continue to play its part in the overall mission of the Church of Scotland, and urge Presbyteries to continue to work with CrossReach in a spirit of collaboration and mutual support.

The Moderator thanked the retiring Convener, the Rev Thom Riddell, on behalf of the General Assembly, for his dedication and commitment as Convener of the Social Care Council. The Moderator also thanked the CrossReach staff for all that they do. Thom had played an essential role in this work and it was apparent how much he has been appreciated.

The General Assembly suspended their sitting at 10.28 am until 10.47 am.

#### **SESSION 9**

#### CHURCH OF SCOTLAND GUILD

The General Assembly called for the Report of the Church of Scotland Guild, which was given in by Mrs Rae Lind, National Convener.

It was moved, seconded and agreed:

# The General Assembly:

- 1. Receive the Report.
- 2. Continue to encourage uniting congregations to ensure that the Guild is involved in discussions and enabled to explore ways in which Guilds merge or work in new ways, welcoming those mergers that have taken place.
- 3. Encourage Kirk Sessions to consider if establishing a Guild can assist in their mission to their local community.
- 4. Welcome the ways in which Guilds are reaching out to local communities and encourage Guilds and congregations to see this as an opportunity for mission together.
- 5. Encourage youth workers, ministers, Kirk Sessions and Presbyteries to support the work of the Young Adult Guild.
- 6. Commend the Guild for the work of its Project Partnership Scheme 2021-24 and recognise the important issues tackled and vital monies raised.
- 7. Congratulate the Guild and the CCAP Synod of Livingstonia on their collaborative working and learning together.
- 8. Commend Guilds Together Groups for exploring new ways of working together and welcome the new structure of Guilds at a Regional Level agreed by the Guild conference.

The Moderator thanked, on behalf of the General Assembly, Mrs Rae Lind, who would be retiring as Guild National Convener in September, for her service to the Church. Rae had offered her time and energy in different

areas of the country and had also been an effective leader. The General Assembly had heard about the Guild's fundraising, and feedback from the ground, and the Moderator asked the Convener to pass on the General Assembly's appreciation to the Guild for all of its work.

#### FAITH ACTION PROGRAMME LEADERSHIP TEAM

The General Assembly called for the Report and Supplementary Report of the Faith Action Programme Leadership Team (including the Overture from the Presbytery of Glasgow and the Overture from the Presbytery of Lothian & Borders) which was given in by the Rev Thomas MacNeil, Convener.

1. Receive the Report.

- 2. Instruct Presbyteries to appoint Church of Scotland representatives to local authority committees which deal with education, according to the principles set out in the report; and affirm the report on Church of Scotland representatives' voting powers on education committees.
- 3. Instruct the Faith Action Programme Leadership Team, in consultation with the Assembly Trustees, to review the Income Protection and III Health Act (Act VI 2019) in light of its operation in practice over the past five years (such review to include consulting with people who have had direct experience of it) and report to the General Assembly of 2025.
- 4. Adopt the 'Terms of Responsibility for Ministers Serving in the Church of Scotland', as contained in Appendix II, as a standard for the duties of the office of Ministry of Word and Sacrament, instruct the Faith Action Programme Leadership Team to make this available to

all Ministers of Word & Sacrament as well as including it in the Ministers' Handbook and encourage ministers to study and adhere to these.

#### PRAISE

- 5. Commend the Church Hymnary Supplement 'God Welcomes All' and thank the Hymnary Supplement Committee for their work in producing this resource of contemporary songs supporting the renewal of worship.

Instruct the Faith Action Programme Leadership Team to conduct research, including consultation with Presbyteries, into the use of local worship leaders and Readers across the church, and to report to the General Assembly in 2025 with recommendations on how these roles should be shaped to best support the emerging shape of the Church of Scotland and its worshipping communities.

#### POVERTY

- 7. Instruct the Faith Action Programme Leadership Team to encourage Presbyteries to engage with Priority Areas to explore ways in which the Church of Scotland's priority for the poorest and most marginalised in society can continue to be delivered in areas where major adjustments have taken place to Priority Area parishes.
- 8. Call for the introduction of a Minimum Income Guarantee and instruct the Faith Action Programme Leadership Team, in consultation with the Theological Forum, to explore theological perspectives on this issue.

The General Assembly agreed that Standing Order 95 be amended to limit the time for speeches to three minutes except those relating to an Overture.

# FAITH ACTION PROGRAMME LEADERSHIP TEAM (CONTD.)

# Main Report

The General Assembly resumed their consideration of the Report of the Faith Action Programme Leadership Team (including the Overture from the Presbytery of Glasgow and the Overture from the Presbytery of Lothian & Borders).

It was moved, seconded and agreed as an amendment of the Deliverance:

Add a new section 4 and renumber:

4. Encourage FAPLT, in relation to the basic level for locum remuneration, to consider moving towards benchmarking this against the real living wage rather than the national minimum wage.

It was moved, seconded and agreed as an amendment of the Deliverance:

Add a new section 5 and renumber:

5. Instruct the Faith Action Programme Leadership Team to consider introducing, in relation to ministers in their First Five Years, an annual two-week allocation for study leave and investigate whether the present financial allocation for the Continuing Ministerial Development Fund can be increased from £200 to £275 for ministers in their First Five Years; strongly encourage all ministers in their First Five Years to utilise the resources available, including the Continuing Ministerial Development Fund, and urge all congregations with ministers in their First Five Years to encourage their minister to take up what is on offer.

It was moved, seconded and agreed as an amendment of the Deliverance:

Add a new section 5 and renumber:

5. Instruct the Faith Action Programme Leadership Team and other relevant parties, recognising the pace of societal change at this time, acknowledging the significance of the recently released Cass Report, and informed by the work done by the Theological Forum on Transgender Identities, to consider the implications of the Cass Report to the work of the Church, particularly amongst young people, and report to a future General Assembly.

It was moved, seconded and agreed as an amendment of the Deliverance:

Add a new section 5 and renumber:

5. Instruct the Faith Action Programme Leadership Team, in consultation with the Assembly Trustees, to review the support which may be provided

to those ministers from overseas who have completed their familiarisation periods and presently seek a charge, with the administrative and financial challenges of renewing visas, and report to the General Assembly of 2025, and in the interim supply any support which may be provided without budgetary implications.

It was moved, seconded and agreed as an amendment of section 6 of the Deliverance:

Delete:

"to conduct research, including consultation with Presbyteries, into"

and substitute with:

"to consult with Presbyteries, Readers and local worship leaders about".

It was moved, seconded and agreed as an amendment of section 6 of the Deliverance:

Add at the end:

"and in the interim encourage Presbyteries to promote the use of Readers already Set Apart and willing to serve."

Section 6 as amended was then agreed.

It was moved, seconded and agreed as an amendment of section 8 of the Deliverance:

Delete:

"and instruct the Faith Action Programme Leadership Team, in consultation with the Theological

Forum, to explore theological perspectives on this issue."

Section 8 as amended was then agreed.

The General Assembly suspended their sitting at 3.30 pm until 3.48 pm.

The General Assembly took up consideration of an Overture from the Presbytery of Glasgow as to the Presbytery Mission Plan Act.

Section 2 of the proposed Deliverance of the Overture was treated as a proposed new section 16 of the Deliverance of the Faith Action Programme Leadership Team.

The Rev Dr Ruth Morrison appeared and moved the Deliverance as follows:

It was moved and seconded:

#### The General Assembly:

- 1. Receive the Overture.
- 2. Determine that all vacant charges which conform to the final position in the Approved Presbytery Mission Plan and which in all other respects qualify for permission to call shall not have such permission withheld by the Faith Action Programme Leadership Team (working through the Presbytery Mission Plan Implementation Group) for the reason only that the number of ministry posts allocated to that Presbytery by the General Assembly has, at that time, been exceeded.

The General Assembly agreed to receive the Overture.

On a vote being taken For or Against section 2 of the Overture, there voted For 147 and Against 197 and it carried Against.

It was moved, seconded and agreed as an amendment of the Deliverance:

Add a new section 16 and renumber:

16. Instruct the Faith Action Programme Leadership Team, in consultation with the Legal Questions Committee, to review the Presbytery Mission Plan Act (Act VIII 2021) and to report to the General Assembly of 2025 with proposed revisions, particularly in relation to team ministry and the adjustment process, and meantime note the willingness of the Principal

Clerk's office to assist Presbyteries with flexible solutions, in particular to issues arising with team ministry.

It was moved and seconded as an amendment of section 16 of the Deliverance:

Add at the end:

And further amend the Act by deleting paragraph 7(10)(e)(E).

On a vote being taken For or Against the second amendment of section 16 of the Deliverance, there voted For 81 and Against 223 and it carried Against.

#### OVERTURE FROM THE PRESBYTERY OF LOTHIAN & BORDERS

The General Assembly took up consideration of an Overture from the Presbytery of Lothian and Borders as to the Presbytery Mission Plan Process.

Section 2 of the proposed Deliverance of the Overture was treated as a proposed new section 17 of the Deliverance of the Faith Action Programme Leadership Team.

The Rev Norman Smith appeared, and Mrs Abigail Morrison appeared in support, and moved the Deliverance as follows:

It was moved and seconded:

#### The General Assembly:

- 1. Receive the Overture.
- 2. Instruct that the Presbytery Mission Plan Act (Act VIII 2021) ("the Act) shall be amended so as to require only comments from FAPLT and the GTs on an annual evaluation and development, with approval

from FAPLT and the GTs only being required every five years, and to that end pass an Act amending the Presbytery Mission Plan Act (Act VIII 2021) as set out in the Appendix to this Overture.

APPENDIX (detailed changes required to the Presbytery Mission Plan Act (Act VIII 2021))

## [ ] ACT AMENDING THE PRESBYTERY MISSION PLAN ACT (ACT VIII 2021) (AS AMENDED)

Edinburgh, [] May 2024, Session []

The General Assembly hereby enact and ordain that the Presbytery Mission Plan Act (Act VIII 2021), as amended, shall be further amended as follows:

- 1. Delete the existing definition of "Approved Mission Plan" and substitute:
- ""Approved Mission Plan" shall mean a Mission Plan that has initially been approved by the Presbytery, FAPLT and the General Trustees and which thereafter has been annually and five-yearly evaluated and developed in accordance with this Act;"
- 2. Delete the existing section 2.1.2(a) and substitute:
- "(a) to be retained beyond the five years from the date of the Approved Mission Plan".
- 3. In section 2.2.2, delete "annual" and substitute "five-yearly".
- 4. Delete the existing section 2.3.2 and substitute:
- "The process of annual evaluation and development of the Mission Plan shall be initiated by the Presbytery, and shall proceed in consultation with FAPLT and the General Trustees but the approval of FAPLT and of the General Trustees to the Mission Plan shall not be required. Once final approval of the Mission Plan following annual evaluation and development is recorded at a meeting of the Presbytery, the Mission Plan shall be re-dated to cover the next five years, becoming the Presbytery's Approved Mission Plan and an extract minute of the Presbytery's decision and a copy of the Approved Mission Plan shall be sent to FAPLT and the General Trustees."
- 5. Add a new section 2.3.3:
- "If a Presbytery fails to carry out an annual evaluation and development of its Mission Plan within a reasonable period of when it was due, a referral

- may be made by the Principal Clerk to the Presbytery Review Committee."
- 6. Add a new section 2.4 headed "FIVE-YEARLY EVALUATION AND DEVELOPMENT OF A MISSION PLAN" and renumber the existing section 2.4 as section 2.5:
- "2.4.1 Each Presbytery shall also carry out a process of five-yearly evaluation and development of its Mission Plan so as to maintain in rolling form an accurate, comprehensive and up to date Mission Plan for the shape of church life in the next five years in that Presbytery.
- 2.4.2 In the year when a five-yearly evaluation and development of a Mission Plan takes place, this process shall replace the annual evaluation and development process set out in section 2.3.
- 2.4.3 The process of five-yearly evaluation and development of the Mission Plan shall be initiated by the Presbytery, and shall proceed in consultation with FAPLT and the General Trustees. Thereafter approval by the Presbytery, and final approval by FAPLT and General Trustees shall be sought and this process shall follow the procedure set out above at section 2.2, save that the period to achieve final approval of the Plan shall be one month rather than three months. After such five-yearly evaluation and development, final approval and recording of that approval at a meeting of the Presbytery, the Mission Plan shall be redated to cover the next five years and that shall become the Presbytery's Approved Mission Plan.
- 2.4.4 The first five-yearly evaluation and development of each Mission Plan shall take place five years after a Mission Plan first became an Approved Mission Plan in terms of section 2.2.6, and thereafter a five-yearly evaluation and development shall take place every five years."
- 7. In the existing section 2.4.2, to be re-numbered 2.5.2, after "annual" add "or five-yearly".
- 8. Delete the existing section 3.1 and substitute:
- "Within fourteen days of the date of the Presbytery meeting at which one of the following has been recorded:
  - (a) the agreement of FAPLT and the General Trustees to the Mission Plan; or

- (b) the approval by Presbytery to an annual evaluation and development of the Mission Plan; or
- (c) the agreement of FAPLT and the General Trustees to a five-yearly evaluation and development of a Mission Plan;

it shall be open to any twelve or more members of the Presbytery or to any Kirk Session within its bounds to seek a review of the process used by the Presbytery in preparing and approving the Mission Plan (or its annual or five-yearly evaluation or development, as the case may be). This shall be done by sending intimation to the Principal Clerk (who in turn shall inform FAPLT and the General Trustees in the case of a first agreement to a Mission Plan or a five-yearly evaluation and development of a Mission Plan)."

- 9. Delete the existing section 4.1 and substitute:
- "After achieving the final approval of FAPLT and the General Trustees to the Mission Plan (or the approval by Presbytery to an annual evaluation and development of the Mission Plan, or of FAPLT and the General Trustees to a five-yearly evaluation and development of a Mission Plan, as the case may be), and when there are no outstanding requests for review to be heard by the Mission Plan Review Panel, the Presbytery shall proceed to implement the Approved Mission Plan."
- 10. In the fifth sentence of section 7(5), after "normal annual" add "and five-yearly".
- 11. In section A2.(b) of the Schedule, delete "2.3" and substitute "2.4" and delete "annual" and substitute "five-yearly".
- 12. In section A2.(c) of the Schedule, after "annual" add "or five-yearly".

The General Assembly agreed to receive the Overture.

It was moved and seconded as a counter-motion to section 2 of the Overture:

Instruct that the Presbytery Mission Plan Act (Act VIII 2021) shall be amended so as to substitute biennial evaluation and development for annual evaluation and development, and to that end pass an Act amending

Add a new section 17 and renumber:

17. Invite the Faith Action Programme Leadership Team to record the number of 'Bases of Adjustment' being processed by Presbyteries (in terms of the various forms of Adjustment referred to in Section 7 of the Presbytery Mission Plan Act (Act VIII 2021)), the time taken to process these and whether or not these Bases were consistent with the relevant Presbytery Mission Plans; and report to the General Assembly of 2025.

Sections 10-14 of the Proposed Deliverance of the Faith Action Programme Leadership Team (these being the only sections of the main Report which had not been considered), along with the Supplementary Report, were remaindered. The Procedure Committee will report on where they will be taken.
