

After public worship in the Assembly Hall, conducted by the Right Rev George Russell Barr BA BD MTh DMin, Moderator of the General Assembly, the Commissioners elected as members of the General Assembly appointed to be held this day convened, and the General Assembly was duly constituted with prayer.

The General Assembly proceeded to the election of a Moderator, when it was unanimously agreed that the Rev Derek Browning MA BD DMin be appointed Moderator.

ASSEMBLY ARRANGEMENTS COMMITTEE

It was moved and seconded-

The General Assembly:

- 1. Receive the Report.
- 2. Approve the Order of Business for the first two days.
- Appoint Mr Roy Pinkerton to index the verbatim record.
- Invite commissioners to submit to the first meeting of the Business Committee nominees for consideration to serve on the Selection Committee.

SCOTTISH BIBLE SOCIETY

It was moved, seconded and agreed as an amendment of the Deliverance:-

Add a new Section 9 and renumber:

Thank the Scottish Bible Society warmly for the ministry of the Bibleworld mobile classroom, and commend to God the faithful work it carried out during the course of its service.

The Deliverance as amended was then agreed.

DELEGATION OF THE GENERAL ASSEMBLY

The General Assembly called for the Report of the Delegation of Assembly which was given in by the Principal Clerk, Chairman.

It was moved, seconded and agreed-

The General Assembly:

- Receive the Report of the Delegation of the General Assembly and thank it for its work.
- Continue the appointment of the Delegation with the same powers as hitherto – the Principal Clerk of the General Assembly to be Chairman, the Depute Clerk of the General Assembly to be Vice-Chairman and the Solicitor of the Church to act as Secretary.
- 3. Pass an Act amending the Congregational Constitutions Act (Act XIX 1964) as set out in Appendix A.

APPEALS COMMITTEE OF THE COMMISSION OF ASSEMBLY

The General Assembly called for the Minutes of the Appeals Committee of the Commission of Assembly which were laid on the table.

RETURNS TO OVERTURES

The General Assembly called for the Report of the Committee on Classifying Returns to Overtures which was given in by the Principal Clerk, Convener.

It was moved and seconded-

The General Assembly:

- 1. Receive the Report.
- 2. Convert into a Standing Law of the Church the Registration of Ministries Overture, as printed in Appendix B.

It was moved, seconded and agreed as an amendment of Section 2:

Add at the end:

with the following additional amendment to Schedule 4 (Amendments and Repeals) of the Overture under the heading **Act VIII 2010 (Deacons)**:

Add the following sentence at the end of section 8(d):

'A Deacon who does not occupy such a parish appointment, or other qualifying post, but who is registered on the Register of Ministry in Category **R**, shall be entitled to apply for membership of Presbytery on the same basis as a Minister of Word and Sacrament holding Category **R** registration, being in terms of section 14 of Act III 2000.'

The Deliverance as amended was then agreed.

The General Assembly suspended their sitting at 12.33 pm until 2 pm.

LEGAL QUESTIONS COMMITTEE

The General Assembly called for the Report of the Legal Questions Committee which was given in by the Rev George Cowie, Convener.

It was moved and seconded-

The General Assembly:

- 1. Receive the Report.
- Amend Standing Order 95(i) as detailed in Section 1 and Appendix A of the Report.
- 3. Approve the principles outlined in Section 2.7 of the Report and instruct the Committee to bring a draft Discipline Overture, written in accordance with these principles, to the Assembly of 2018.
- 4. Instruct the Committee, jointly with the Ministries Council, to consider whether there is scope to reformulate the Code of Professional Practice and Good Conduct for the Ministries of the Church of Scotland as a set of rules which might allow breach of the Code, or of a version of it, to be defined as a disciplinary offence, and to report to the General Assembly of 2019.
- 5. Note that the Unitary Constitution has been amended (a) to include reference to the requirement to hold a Stated Annual Meeting and (b) to correct a reference to an appeal process, and agree to amend the Model Deed to similar effect, all as outlined in Appendix C.
- Pass an Act amending the Model Deeds of Constitution Act (Act II 1994) as set out in Appendix C.
- 7. Agree that the process known as 'Arbitration', which has been used to make decisions between buildings in certain readjustment cases, should cease to be available from 1 January 2018.

- 8. Instruct Presbyteries to review any agreed Bases of Union or Linking which have yet to be implemented and, where any such Basis includes a clause indicating that the Panel of Arbiters should be asked to a choose a building, instruct the Presbytery to amend its Plan by categorising the buildings in the proposed Union or Linking in terms of section 5(2) of Act VII 2003.
- Instruct the General Trustees, in consultation with the Central Properties Department, to compile a guidance document for Presbyteries, outlining good practice which can be employed when choosing between buildings in the appraisal process.
- Instruct the Committee, in consultation with the Ministries Council, to revise and consolidate the provisions of the Ministries Act, as outlined in the Report, and to report to the Assembly of 2018.
- 11. Pass an Act amending the Ministry Act (Act II 2000) as set out in Appendix D.
- Instruct the Committee to undertake a consultation exercise in relation to membership of Church Courts and to report to the Assembly of 2018.

It was moved, seconded and agreed as an amendment of Section 9:

After 'Instruct the General Trustees, in consultation with' add 'the Committee on Church Art and Architecture and'.

The Deliverance as amended was then agreed.

COUNCIL OF ASSEMBLY

The General Assembly called for the Report and Supplementary Report of the Council of Assembly which were given in by Dr Sally Bonnar, Convener. It was moved and seconded-

The General Assembly:

- 1. Receive the Report and Supplementary Report.
- Issue a call to the Church of Scotland to pray that God will do a fresh work amongst us as God's people and instruct Presbyteries and Kirk Sessions to consider how best to respond to this call.
- Instruct the Council, working together with other appropriate Councils, to prepare as soon as possible, resources to support individuals, congregations and Presbyteries in prayer for the development and implementation of the Strategic Plan.
- 4. Affirm the work undertaken to this point on the creation of a Strategic Plan for the Church and note the Council's intention to bring a full report indicating strategic priorities for the next phase of the Church's life and work to the General Assembly in 2018.
- 5. Welcome the report of the Council's review of the work of the Ecumenical Relations Committee and instruct that Committee to continue its own review of the Church's Ecumenical Policy in consultation with the Council of Assembly, reporting to the General Assembly in 2018.
- 6. Approve the revised Remit of the Ecumenical Relations Committee as set out in Appendix 3.
- 7. Affirm the planned changes to the way in which the Ecumenical Relations Committee intends to relate to Councils and the Theological Forum and instruct those bodies to engage appropriately.
- 8. Encourage Presbyteries and congregational office bearers to ensure local compliance with the Data Protection Act and instruct the Council to present to the General Assembly in 2018 measures to ensure ongoing compliance throughout the Church

- with the new General Data Protection Regulation being introduced across the European Union.
- Affirm the work undertaken by the Council in benchmarking senior staff salaries.
- 10. Approve the revised Job Description for the post of Principal Clerk as set out in Appendix 4.
- 11. Consideration of Section 11 was dealt with earlier in this Session.
- 12. Instruct the Council, in cooperation with the Assembly Arrangements Committee and the Legal Questions Committee, to review the terms and processes relating to the future appointment of a Principal Clerk and report to the General Assembly in 2019.
- Note the Council's report on the future of interfaith relations and affirm the ongoing development of this work.
- 14. Approve the total to be contributed by congregations in 2018 of £46,055,000 based the projection on congregational income for 2018 and disposition among local congregational expenditure. the Parish Ministries Fund and the Mission and Renewal Fund. (Section 1 and Appendix I)
- 15. Note the indicative budget for 2018.
- Receive the 2016 Report and Accounts of the Unincorporated Councils and Committees of the General Assembly.
- 17. Consideration of Section 17 was deferred until Session II.

It was moved, seconded and agreed as an amendment of the Deliverance:

Add a new Section 8 and renumber:

Welcome the establishing of the Gaelic Working Group and encourage the Group to press forward timeously with the development of the Gaelic language plan for the Church, and with other activities aimed at encouraging the use and enlivening of Gaelic in the Church.

It was moved, seconded and agreed as an amendment of the Deliverance:

Add a new Section 8 and renumber:

Instruct the Council, in consultation with the Nomination Committee, to investigate the opportunities, costs and financing of making video-conferencing more widely available for meetings of the Councils and Committees of the Church and report to the General Assembly in 2018.

The Deliverance as amended was then agreed.
